

BECU MONEY MANAGER TERMS AND CONDITIONS AND MONEY DESKTOP END USER LICENSE AGREEMENT



Money Manager Services

You are accessing services (“Services” or “Service”) provided to you from Boeing Employees’ Credit Union (“BECU”) by way of our third party service provider, Money Desktop. You are being asked to agree to the legally binding agreements: BECU Money Manager terms and conditions, Money Desktop’s End User License Agreement, and BECU’s Privacy Policy, all as provided below or accessed by link (“Terms”). Therefore, we encourage you to read this thoroughly and carefully.

These Terms constitute an agreement between you (“you”, “your”, or “user”) and BECU including our affiliates and third party service providers (“BECU”, “our”, “we” or “us”), and Money Desktop, pertaining to your use of the Services. If you are using this Service over mobile networks you understand that the Service may not be accessible or may have limited utility over some mobile networks, such as while roaming. By using the Services, you agree to be bound by these Terms.

Accepting the Terms

BY USING ANY PART OF THE SERVICES, YOU EXPRESSLY (a) ACKNOWLEDGE THAT YOU HAVE READ ALL OF THESE TERMS; (b) AGREE AND CONSENT TO THE TERMS; (c) REPRESENT AND WARRANT THAT YOU: (i) IF YOU ARE AGREEING TO THESE TERMS ON BEHALF OF A BUSINESS ENTITY OR ANOTHER INDIVIDUAL, ARE AUTHORIZED TO BIND SUCH ENTITY OR SUCH INDIVIDUAL, AND (ii) AGREE TO BE BOUND BY THE TERMS, INCLUDING THE DISCLAIMERS AND LIMITATIONS OF LIABILITY; AND (d) AGREE TO BE LIABLE FOR ANY NONCOMPLIANCE WITH THESE TERMS. IF YOU DO NOT AGREE TO ANY OF THE TERMS, DO NOT CLICK THE ACCEPT or AGREE BUTTON, AND DO NOT ACCESS OR USE THE SERVICES.

BECU may, from time to time, update these Terms and your continued use of the Services indicates your agreement to any modification of these Terms. You may not use the Services and may not accept the Terms if you are incapable of entering into a binding contract with BECU.

BECU and Money Desktop are not responsible for and make no warranties that your equipment or software is or will continue to be compatible with the use of the Services.

The Service provided by BECU and Money Desktop is not intended to provide legal, tax, or financial advice. The Service is not a financial planner, broker or tax advisor. The Service is intended to assist you in organizing your financial and account information and is broad in scope. You should not rely on the information provided in the Service when making financial decisions, but instead you should consult with your accountant or other financial professional who is fully aware of your circumstances before making any decisions concerning your finances.

Services

Money Manager is a free personal financial management tool that allows you to upload financial and account information and include it in a portfolio accessible from BECU’s Mobile and Online Banking platform, from where you may access, retrieve and maintain financial information. You may upload any financial information and accounts that are available to you from other, non-BECU institutions. You may organize, consolidate, view and, track your financial and account information all in one location (“Services”) through the Online Banking platform. Through the Service, you may request that certain alerts concerning your financial information and account usage and status be delivered via SMS and/or email (“Alerts”). The Service automatically uploads your BECU accounts and they are included in your Money Manager portfolio along with any other non-BECU accounts that you upload to your Money Manager portfolio and made accessible in either Online or Mobile Banking. From time to time BECU may modify the Services and add, change, or delete features of the Services, in its sole discretion, without notice to you.

You agree to provide accurate, current and complete information about your accounts at other banks, organizations, or institutions when uploading them to your portfolio, and to maintain and update this information to keep it accurate, current and complete. You agree to not misrepresent your identity or your account information. You agree to maintain the safety and security of access devices used to access Mobile and Online Banking. Failure to provide accurate and complete information during account setup may prohibit your use of the Services or result in errors in information generated.

You are solely responsible for:

- (a) maintaining the confidentiality and security of your login information, passwords, and any other security or access information used by you or anyone you authorize on your behalf to access the Services (collectively, “Login Information”),
- (b) preventing unauthorized access to or use of information, files, financial information or account data, that is stored or used in or with the Services (collectively, “Account Data”),

(c) all electronic communications, including account holder information, email and financial, accounting and other data entered into the Service (“Communications”),

(d) any and all activities involving or effecting your financial information and accounts uploaded to the Service and.

(e) maintaining the safety and security and preventing unauthorized use of all mobile devices, computers, other devices used by you or anyone you authorized on your behalf to access the Services (collectively, “Access Device”).

BECU shall assume that any Communications received through use of the Login Information were sent or authorized by you. You agree to immediately notify BECU if you become aware of any loss, theft or unauthorized use of any Login Information or Access Device. We reserve the right to deny you access to the Services (or any part thereof) if we reasonably believe that any loss, theft or unauthorized use of Login Information or Access Device has occurred.

You hereby grant to BECU and its affiliates, Money Desktop, partners, licensors, employees, distributors and agents permission to use the Login Information to enable BECU to provide the Services to you, including updating and maintaining Account Data, addressing errors or service interruptions, and to enhance the types of data and services BECU may provide to you in the future.

BECU and its affiliates, Money Desktop, partners, licensors, employees, distributors and agents may use, modify, display, distribute and create new materials using the Login Information, Account Data and/or your Communications to provide the Services to you. By submitting Login Information, Account Data and Communications, you agree that BECU may use your Login Information, Account Data and Communications for the purposes such as to send you marketing information regarding opportunities to refinance loans or to market other opportunities to you, all without any particular time limit and without BECU’s payment of any fees.

Anonymous, aggregate information that does not contain personally identifiable information, financial account balances, other financial or account data, or other available data that is collected through your use of the Services, may be used or licensed by Money Desktop for various purposes including but not limited to conducting certain analytical research, performance tracking, benchmarking (for the purpose of helping to improve products and services) and to assist in troubleshooting and technical support.

To the extent that you request customer service or other assistance from BECU or Money Desktop, you agree that BECU and our third party service provider are authorized to access and view your Login Information, Account Data, and Communications to provide such assistance and support.

User Risks

Data and information provided by the Service is provided for informational purposes only, and is not intended for trading, investing or transactional purposes. You agree that we and Money Desktop are not liable for any errors or delays in the content, or for any actions taken in reliance on the data or information available in the Service. The services associated with non-BECU accounts, which you may be able to access through the Service are not BECU services; they are services of the account holding institutions you upload to your Money Manager portfolio. The Service provides links to selected institutions for your convenience only. We do not endorse or recommend the services of any institution. The third party institution you select is solely responsible for its services to you. We are not liable for any damages or costs of any type arising out of or in any way connected with your use of the services of the institution. You may also add information into your Money Manager portfolio for accounts not available at other web sites or which are not linked to the Service. In such case, you are solely responsible for the accuracy of such information.

Indemnification

You agree, at your expense, to defend, indemnify, hold harmless, protect and fully compensate BECU and Money Desktop, our affiliates, and their respective officers, directors, employees, consultants, agents, distributors, partners, licensors and third-party providers from any and all claims, liability, damages, losses, expenses and costs (including attorneys' fees) caused by or arising from (a) a third-party claim, action or allegation of infringement based on your use of the Service or information, data, files or other content you submitted or uploaded; (b) any fraud, manipulation, or other violation of Law by you; (c) a breach of these Terms by you; (d) your acts or omissions; or (e) any third-party claim, action or allegation brought against BECU and/or Money Desktop arising out of or relating to a dispute between its users over the terms and conditions of a contract or related to the purchase and sale of any services. For the avoidance of doubt, if you are a business entity, your obligations hereunder shall extend to indemnification based on the acts and omissions of your employees, consultants and agents.

Third Party Institutions

In connection with your use of the Services and as part of the functionality of the Services, you may have access to certain online account information that may be made available by your bank, organizations, other institutions including non-BECU account information available from others. BECU has no control over the provision of or access to Account Data.

BECU does not guarantee your Institutions' services. You agree that you may or may not be able to use the Services in conjunction with your Institutions' services, and that BECU and Money Desktop disclaims any and all liability whatsoever for any actions or inactions on the part of your Institutions resulting in any inability to use the Services to access accounts, obtain data, download transactions, or otherwise use or access your Account Data.

You acknowledge and agree when you access data and information through the Services, your account access number(s), password(s), security question(s) and answer(s), account number(s), login information, and any other security or access information, and the actual data in your user account(s) with such Institution(s) such as banks and other account holders, including balances, credit card charges, debits and deposits as may be applicable, may be collected and stored in the Services by BECU and Money Desktop.

You expressly authorize BECU and Money Desktop, in conjunction with the operation and hosting of the Services, to use your Login Information to (i) collect Account Data, (ii) reformat and manipulate Account Data, (iii) create and provide hypertext links to provider(s), (iv) access the providers' websites using your Login Information, (v) update and maintain account information, (vi) address errors or service interruptions, (vii) enhance the type of data and services we can provide in the future, and (viii) take such other actions as are reasonably necessary to perform the actions described in (i) through (vii) above.

In accessing and using the Services you represent that you are the legal owner of the Login Information and Account Data and that you have the authority to appoint, and do expressly appoint, BECU or Money Desktop as your agent with limited power of attorney to access and retrieve Account Data on your behalf. You further acknowledge that BECU does not (nor does Money Desktop), review Account Data for completeness or accuracy and further you agree that we are not responsible for its completeness or accuracy.

Any transactions or informational activities performed directly at any Institutions' website are not made through the Services and BECU and Money Desktop assume no responsibility for such transactions or activities. You acknowledge that you are solely responsible for any charges associated with your Institutions(s).

You acknowledge and agree that when BECU or Money Desktop access and retrieve your Account Data, BECU and Money Desktop are acting as your agent and the agent on or behalf of providers.

You further acknowledge and agree that (i) some Institutions may not allow the Services to access the Account Data, (ii) Institutions may make changes to their websites, with or without notice to BECU or our third party service provider, that may prevent or delay aggregation of information from such Institutions' websites, (iii) the Services may "refresh" the Account Data by collecting the Account Data nightly, so your most recent transactions may not be reflected in any account balances or other account information presented in the Services, and (iv) any Alerts you establish for accounts uploaded to the Service may be delayed as a result of the other institutions' delay in making information available to the Service.

In the event that you see a discrepancy in the Account Data, and in any case before making any transactions or decisions based on such Account Data presented in the Services, you agree to check the last refresh date for the account and confirm with that applicable Institution that the Account Data is correct or otherwise confirm that Account Data is up to date and accurate.

Alerts and SMS Notification Program

You may opt-in to have transaction and account Alerts such as for a low account balance, large transactions, or budget you set be delivered to you by way of SMS and/or email. If you opt-in, you will also initially receive a text message to verify your phone number.

You can cancel the SMS Alerts service at any time. Just text "STOP" to the short code. After you send the SMS message "STOP" to us, we will send you an SMS message to confirm that you have been unsubscribed. After this, you will no longer receive Alerts from BECU or Money Desktop. If you want to opt-in to receive Alerts again, just sign up as you did the first time and you will start receiving SMS Alerts messages again.

If you are experiencing issues with the SMS Alerts messaging program you can reply with the keyword HELP for more assistance, or you can get help directly at 800-233-2328.

Carriers nor BECU or Money Desktop are liable for delayed or undelivered messages.

As always, message and data rates may apply for any SMS messages sent to you from BECU or Money Desktop and to BECU or Money Desktop from you. Message frequency varies. If you have any questions about your text plan or data plan, it is best to contact your wireless provider.

Net Worth

You may add a home value estimate to your Money Manager portfolio when calculating your net worth. If you elect to include your home's value in your net worth summary, you acknowledge and agree that the net worth summary is calculated based on information provided by you at your direction and that BECU and Money Desktop make no representation as to the accuracy of the net worth summary. **Data and information provided in the Net Worth feature is for informational purposes only, and is not intended for transactional purposes.** You agree that BECU, and/or Money Desktop are not liable for any errors or delays in the content, or for any actions you take in reliance on data and information contained in the Net Worth feature.

Modifications

BECU may modify, discontinue temporarily or permanently, the Service without notice to you. You may reject the changes by discontinuing your use of the Service. Your continued use of the service will constitute your acceptance of and agreement with such changes. Maintenance upon the Service may be performed from time to time resulting in interrupted service, delays or errors in the service. BECU and Money Desktop shall not be liable to you or any third party should we exercise our right to modify or discontinue the Service.

Delete Non-BECU Accounts

You may delete previously uploaded non-BECU accounts from your portfolio at any time by selecting an account within your Money Manager portfolio and clicking on the 'Delete' button. The deleted account will be removed from your portfolio. **Some of your Account Data will remain stored by Money Desktop.**

Termination of Service

BECU or Money Desktop may at any time terminate your access to the Services for any reason, including:

- 1) You have breached a provision of these Terms, including Money Desktop's End User License Agreement and/or Money Desktop Privacy Policy, or have acted in a manner which shows you do not intend to or are unable to comply with provisions of these Terms, Money Desktop's End User License Agreement and/or the Money Desktop Privacy Policy;
- 2) We and Money Desktop are required to do so by law;
- 3) BECU has terminated its relationship with Money Desktop or has ceased to offer the Service to you;
- 4) We or Money Desktop has deemed the Service no longer commercially viable.

Limitations

Your right to use the Services is personal to you and is not transferable by you to any other person or entity. You represent and warrant that: (i) none of your Account Data violates any third party's copyright, patent, trademark, trade secret or other proprietary or intellectual property rights or rights of publicity or privacy (collectively, "Intellectual Property Rights"), and (ii) you have obtained all consents and waivers required under all applicable local, state, national and international laws, rules, statutes, treaties and regulations (including those governing account collection, export control, consumer protection, data privacy, unfair competition, anti-discrimination and false advertising) (collectively, "Laws") for the provision, manipulation, retention, use and sharing of personal data of individuals (including you) with respect to whom information is supplied by you as part of your use of the Services, and that you will retain all such consents and waivers and/or provide them to Money Desktop at any time upon request.
