This form allows you to transfer to another member's deposit account without being added as a signer. Web authorization cannot be set up for loan accounts. Please complete this form to authorize a new funds transfer to a third party's account or to cancel an existing transfer authorization.

Note: "Account holder" is a term for a consumer account, but also applies to an Authorized Signer on a business account.

- A third party's account appears in both Online Banking and Mobile Banking. The account can accept funds transfers, including mobile check deposits.
- Completed funds transfers to a third party's account are final. If this account is accidentally selected, the member must reach out to the third party account owner to recover the funds.
- Web access transfers CANNOT be set up for UTMA accounts, Benevolent accounts, Blocked accounts, Representative Payee accounts, Estate accounts, Guardianship accounts, or Club/Association accounts.
- Web access authorizations will remain in effect until cancelled by the Member completing this form. BECU reserves the right to cancel web access transfers at any time without notice.
- If the request to TRANSFER FROM is for a minor (under 18), both the minor AND a parent/legal guardian on the Early Saver account must sign this form.
